1. Objective

PathwAI Labs's Code of Business Conduct policy outlines the company's expectations regarding employees' behavior towards their colleagues, supervisors, and the overall organization.

PathwAI Labs promotes freedom of expression and open communication. All staff members are expected to follow the code of conduct. Staff members should avoid offending others, participating in serious disputes, and disrupting our workplace. PathwAI Labs also expects all staff members to foster a well-organized, respectful, and collaborative environment.

This policy outlines the expectations for all PathwAI Labs staff and the consequences for unacceptable behavior.

2. Scope

This policy applies to all PathwAI Labs staff members. Staff members include employees (both full-time and part-time) as well as contractors, regardless of the employment agreement or the level of seniority. PathwAI Labs staff members are expected to follow this policy in all matters pertaining to their work.

3. Policy Statement

PathwAI Labs is committed to creating and maintaining a professional and respectful work environment. This policy describes the desired behavior of all staff members and emphasizes the importance of diversity and inclusion in the workplace.

4. Guidelines

- Be welcoming, friendly, and patient.
- Be considerate. Other people will use your work, and you, in turn, will depend on the work of others. Any decision you make will affect users and colleagues, and you should take those consequences into account when making decisions.
- Be respectful. Not all of us will always agree, but disagreement is no excuse for poor behavior and manners. Everyone experiences some frustration occasionally, but one cannot allow that frustration to become a personal attack. It's important to remember that an organization where people feel uncomfortable or threatened is not productive. PathwAI Labs Staff should be respectful when dealing with other staff.
- Be careful with the words that you choose. Remember that sexist, racist, and other exclusionary jokes can offend those around you. Be kind to others. Do not insult or put down others. Behave professionally. Remember that harassment and sexist, racist, or exclusionary jokes are inappropriate for the organization. Such unacceptable behavior includes, but is not limited to:
 - Violent threats or language directed against another person. Discriminatory jokes and language
 - Posting sexually explicit or violent material.

- Posting (or threatening to post) other people's personally identifiable information ("doxing"). Personal insults, especially those using racist or sexist terms.
- Unwelcome sexual attention.
- Advocating for or encouraging any of the above behavior.
- Repeated harassment of others. In general, if someone asks you to stop, then stop.
- When there is a disagreement, efforts should be made to try to understand why. Social and technical disagreements happen all the time, and PathwAI Labs is no exception. Disagreements and differing views must be resolved constructively. Remember that everyone is different. Different people have different perspectives on issues. Being unable to understand why someone holds a viewpoint doesn't mean they're wrong. Remember that it is human to err. Blaming each other doesn't help. Instead, offer to help resolve issues and to help learn from mistakes.
- The company requires that all staff members demonstrate commitment to impartially treating all people and organizations with whom they come into contact or conduct business. Unsolicited gifts or entertainment may only be accepted if they do not go beyond common courtesy and do not have a risk of influencing any business decisions.
- PathwAI Labs requires all staff members (including senior management) to disclose any personal relationships, business transactions, and related parties that might cause reputational/financial harm to the organization while benefiting them.
- PathwAI Labs requires all staff members that they do not offer, give, receive, or solicit anything of value to influence an official act by a public official, agent, or government employee.
- PathwAI Labs prohibits all staff members from bribing foreign officials as well as making unauthorized facilitation payments to those individuals involved in customs, permitting the flow of goods and other activities.
- The company understands the importance of anonymous reporting requirements and shall implement a confidential reporting mechanism that allows employees, contractors, and other stakeholders to report concerns regarding potential misconduct, policy violations, or legal breaches anonymously. Reports can be made through [insert anonymous email address, platform, or hotline], ensuring that the identity of the whistleblower remains protected. All submissions will be thoroughly investigated with discretion, and the company strictly prohibits any form of retaliation against individuals who raise concerns in good faith. This policy supports our commitment to ethical conduct and compliance with applicable laws and regulations.
- Our disciplinary policy is designed to ensure a fair and consistent approach to addressing any breach of company policies, misconduct, or failure to meet performance expectations. Disciplinary actions may include as below depending on the severity of the violation.:
 - verbal or written warnings,
 - suspension,
 - reprimand,
 - demotion,
 - termination for more serious offenses,
 - detracting of benefits for a definite or indefinite time.
- The process will involve a thorough investigation of the issue, and the employee will be given an opportunity to respond to any allegations. Our goal is to address issues constructively while maintaining the standards of behavior and performance necessary for the success of the company. The company reserves the right to take appropriate disciplinary

measures based on the circumstances, always adhering to principles of fairness and respect for all individuals involved.

5. Reporting Violations

If you are a victim of or notice unacceptable behavior, please notify your reporting manager or anyone up the reporting structure, including the CEO.

Note that this policy does not allow retaliation against a person for reporting unacceptable behavior or participating in an investigation of any such report. Disciplinary actions listed below also apply to any such retaliation or intimidation.

6. Document Security Classification

7. Non-Compliance

Compliance with this policy shall be verified through various methods, including, but not limited to, automated reporting, audits, and feedback to the policy owner. Any staff member found to be in violation of this policy may be subject to disciplinary action, which may include termination of employment or contractual agreement. The disciplinary action shall depend on the extent, intent, and repercussions of the specific violation.

8. Responsibilities

The Information Security Officer is responsible for approving and reviewing policy and related procedures. Supporting functions, departments, and staff members shall be responsible for implementing the relevant sections of the policy in their area of operation.

9. Schedule

This document is to be reviewed annually and whenever significant changes occur in the organization.
